- (i) Application 20/0693 Willows Club, Bryning Fern Lane, Kirkham. Retrospective Application for erection of timber smoking shelter to front of Club. That this application be refused. Given the large volume of complaints from residents in relation to the operation of this Club the Town Council believe that to place this shelter at the rear of properties could well result in greater noise nuisance, it is felt that the siting should be revised and the shelter moved to an area which would not cause nuisance to residents in close proximity to the structure, the Council hope this can be achieved to allow residents a quality of life they are entitled to have.
- (ii) Application 20/0618 34 Poulton Street, Kirkham, amendment to the original application to extend the hours of opening from 11.00.a.m., - 11.00.p.m., to 11.00.a.m. to midnight on Sunday to Thursday and 11.00.a.m. to 02.00.a.m., on Fridays and Saturdays. That this amendment be refused on the grounds that these extended hours will be at odds with all other takeaways in the town, and could lead to noise nuisance in the town centre at an unacceptable hour.
