25/05/06 MATTERS ARISING

Matters arising from the previous meeting were addressed as part of the agenda, except for:

(i) Memorial Park Leak

The Town Clerk reported that the leak in Memorial Park has been repaired.

(ii) Parking on Eagles Court and outside Ash Tree House

Cllr. Hopkinson outlined the agreement with Ash Tree House and Fylde Council to free up the 'GP Only' bay on Church Street in return for a parking space on Eagle's Court car park. The marking out of the bay on Eagle's Court has been completed.

Members discussed other areas in Kirkham that are problematic in respect of parking.

(iii) Banking Hub

Cllr. Hopkinson informed the members that the banking hub is fully operational.

(iv) Memorial Bench

The Town Clerk informed the members that residents have contributed to the Memorial Bench for Gwyn Bradley. The Town Council had previously agreed to fund any shortfall. At this stage it is unclear if the Town Council will need to contribute too, this will depend on the type of bench chosen.

(v) Admin Support Officer

The Admin Support Officer has been appointed.

25/05/07 MAYORS ANNOUNCEMENTS

(i) Events Attended

The Mayor has attended the VE Day events in People's Park and at Blackburn Cathedral. He has also attended the Spring Concert at Kirkham Grammar School.

(ii) Marking of Mill Street Car Park
